4. **Transfer Applicants:** An official transcript evaluation done by BMCC's Records Office, a recent (within 1 year) letter of good academic standing from the Nursing Program Director, **and** a written letter requesting transfer placement to the nursing program.
5. **OTHER COLLEGE TRANSCRIPTS:** If you wish credits from other colleges to be evaluated and considered to meet program entry requirements you must attach official sealed transcripts from those colleges and/or universities with your application packet. **Note:** BMCC only accepts credits from regionally accredited colleges.
6. **Criminal background check.** BMCC must receive the results of your criminal background check from the Oregon State Police (OSP) on or prior to final admission. Results received after that date will not be considered.
7. Signed Nursing Statement of Understanding and Compliance.
8. Non-refundable application fee of \$50 (check, cash, or credit card)

All applicants will receive an email confirmation of receipt of application to their assigned BMCC email account. All required documentation is the full responsibility of the applicant. Failure to provide all required documentation, including contact information, will invalidate the application.
